The successful bidders on award of the contract will lift the material within 15 days from the date of allotment; failing which the amount deposited will be forfeited. Further, the bid/auction process will remain subject to the following terms;

- The agency or persons interested in bidding may deposit the EMD amount of Rs. 2000.00 in Institute account No. **11381956016** Bank name: State Bank of India, Branch: Rawalpura, IFSC: SBIN0006868. Neither cash nor cheque will be accepted as EMD and only such agency or person will be allowed in bidding who submits the proof of deposition of the EMD;
- The highest bidder or successful bidder will have to deposit the performance security equal to **5% of the contract value** and will remain available with Institute till all the material is lifted from the Campus;
- The agency declared successful will deposit full and final payment on award of the contract immediately or preferably within 3 working days from the date of issue of AoC;
- No manpower for assistance or any machinery of the Institute will be provided to the successful bidder for execution of the contract;
- Any dispute arises, the decision of the Director shall be final and binding of the parties;
- Other conditions as per GoI/ICAR norms.**
