On behalf of the Secretary, ICAR, the Director, ICAR-Central Institute of Temperate Horticulture, Srinagar has been pleased to invite the agencies/persons for submission of bids for auction of Walnut crop (Nuts only) on standing walnut trees at ICAR-Krishi Vigyan Kendra, Kuzer, Baramulla (J&K) and offers should reach to this office latest by **17.08.2023** up to **1.30 PM**. The interested agencies/persons offering the bids are free to visit the campus of the KVK, Baramulla situated in village Magloora, Kunzer, District Baramulla, to take stock of the material reserved for auction (Approximately 131 plants). The terms and conditions of the auction will be as appended:

- The agencies/persons have to submit their offers through speed post or through Courier only and ensure submission before fixed date and time. Any delay in submission will be responsibility of the agency.
- The agencies/persons submitted the bids must enclose the EMD of Rs. 4000/- in shape of DD/FDR/TDR/Bank guarantee of any nationalized bank favouring to ICAR-CITH, Srinagar or the Director, ICAR-CITH, Srinagar.
- The successful bidder has to deposit the full auction amount in the Institute account (Account No. 11381956016 Name of the Bank: State Bank of India, IFSC code: SBIN0006868, Branch: Rawalpura); through electronic transfer after receiving the award of contract immediately preferably within 3 (Three) working days and before start of harvesting of the crop, whichever is earlier;
- Failure in deposition of the amount, the EMD deposited will be forfeited besides other administrative action which includes the agency will be debarred from offering bids for such nature of auctions for a minimum period of one year;
- The successful bidder has to submit an agreement on Non-Judicial paper of Rs. 100/- which contains additional terms of the contract;
- The agency after depositing the full auction amount, will harvest the crop within 10 days and shift the material from the campus of the KVK, Baramulla.
- Any damage occurring to the plants while harvesting, the agency will be responsible and will be compensate the damage to be assessed by the Unit Head..

The Director, ICAR-CITH, Srinagar reserves the right to accept or reject any or all offers without assigning any reasons thereof. In case, the bid is received below the assessed estimated cost, the decision of the Director, ICAR-CITH, Srinagar shall be final and binding upon the contractors/agencies/persons involved in the bid process.
