4. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- 1. The service provider must have valid ESI and EPG registration.
- 2. In case of tie, automatic random L1 selection process on GeM or scoring based on f ormula using Gem rating, turn over and number of similar projects completed by the service provider will be used. GeM rating of service provider will carry maxim um 10 points for 5 star rating and calculated accordingly. Maximum turnover of 1 crore will carry 10 points and 60 lakhs will carry zero points (minimum qualificati on). Number of similar projects completed will carry maximum ten points for 5 completed projects and zero points for one completed project during the last 5 years.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
