Selection criteria:-

50 marks for M.Sc, 05 marks for Ph.D. 10 marks for publications(one mark for each publication), research experience 05 marks (one mark for each completed year), 05 marks for NET, 05 marks for awards (one mark for each award), 20 marks for personal interview.

NOTE:-

- Candidates willing to reside inside the campus shall be given preference for which they have to submit necessary undertaking with their application format by specifically mentioning their intention for staying inside the campus.
- Research Fellows will be provided hostel accommodation whenever available. Research fellowship holder residing in hostels shall not be entitled for HRA. Whenever provision of hostel accommodation is not possible, HRA will be allowed to JRF as per Central Government norms applicable in the city/location where he/she is will be posted. The percentage required for calculating HRA will be based on the fellowship amount.
- The JRF are eligible only for casual leaves as per rules of the host Institution. Particiaption of any of scientific events/workshops held in India or aborad will be treated as "on duty" with due approval of the host Instituion. The travel entitlement of JRF for participation in scientiffic events/workshops in India will continue to be same as earlier i.e, 2nd AC by rail. Maternity leave as per the Govt. of India instructions issued from time to time would be available to female candidates in all categories.
- He/She shall be governed by the dicipilanary regulations of the host Institute where he/she is working.
- The JRF must send a report of the research work done during the periods of Fellowship as may be asked by the sponsoring agency.
- The upper age limit for Men is 35 years & for Women it is 40 years. Age relexation will be as per rules of Govt. of India/ ICAR.
- Selected candidates for the position of JRF will be paid emoluments as per norms of Govt. of India/ ICAR.
- No Objection Certificate from the employer/University, in case he/she is employed.
- Candidate is engaged on need basis (contractual) and can be discontinued at any time when such need is not there.
- The appointment of JRF would be on full time basis and he/ she would not be permitted to take up any other assignment during the period of engagement with ICAR-CITH, Srinagar.
- The selected candidates shall not claim for any regular appointment as the positions are purely temporary.
- No TA/DA will be paid for attending the Walk-in-Interview.
- The Director, ICAR-CITH, Srinagar reserves the right to terminate his/her services without any notice at any time and the decision of the Director, ICAR-CITH, Srinagar will be final and binding in all respect.
- Candidates shall bring original qualification at the time of interview for verification alongwith one full copy of marksheets duly self attested, publications, experience, and other documents.
