The open auction of the material will be held on **22.08.2024 (Thursday) from 11:30 am** in committee hall of the Institute. The agencies/auctioneers are free to submit the rate either for the full quantity or per quintal basis and bid will be decided which will be beneficial to the Institute/government exchequer. The successful bidders on award of the contract will lift the material within 15 days from the date of allotment; failing which the amount deposited will be forfeited. Further, the bid /auction process will remain subject to the following terms:

- The agency or persons in bidding may deposit the EMD amount of Rs. 2000.00 in Institute account no. 11381956016 Bank Name, State Bank of India Branch Rawalpura IFS code: SBIN0006868. Neither cash or cheque will be accepted as EMD and only such agency or personal will be allowed in bidding who is submitting the proof of deposition of the EMD;
- The highest bidder or successful bidder will have to deposit the performance security equal to 5% of the contract value and will remain amount with the Institute till all the material is lifted from the campus.
- The agency declared successful will deposit full and final payment on award of the contract immediately or preferably within 3 working from the date of issue of AoC;
- No manpower for assistance or any machinery of the Institute will be provided to the successful bidder for execution of the contract;
- Any dispute arises, the decision of the Director shall be final and binding on the parties;
- Other conditions as per GoI/ICAR norms.
