NOTE:-

- Candidates willing to reside inside the campus shall be given preference for which they have to submit necessary undertaking with their application format by specifically mentioning their intention for staying inside the campus.
- Project Associates and Young Professionals will be provided hostel accommodation whenever available. Project Associate holder residing in hostels shall not be entitled for HRA. Whenever provision of hostel accommodation is not possible, HRA will be allowed to Project Associates as per Central Government norms applicable in the city/location where he/she is will be posted. The percentage required for calculating HRA will be based on the basic amount.
- The Project Associates & Young Professionals are eligible for casual leaves and restricted holidays as per rules of the host Institution. Participation of any of scientific events/workshops held in India or abroad will be treated as "on duty" with due approval of the host Institution.
- He/She shall be governed by the disciplinary regulations of the host Institute where he/she is working.
- The PA and YP's must send a report of the research work done during the periods of Fellowship as may be asked by the sponsoring agency.
- Candidates applying for the position of YP should be above 21 years and below 45 years and for Project Associate-I the candidates should be below 35 years as on 13.05.2022. Age relaxation will be given to the candidates as per the GoI/ICAR guidelines.
- No Objection Certificate from the employer/University, in case he/she is employed.
- Candidate is engaged on need basis (contractual) and can be discontinued at any time when such need is not there.
- The appointment of PA & YP's would be on full time basis and he/ she would not be permitted to take up any other assignment during the period of engagement with ICAR-CITH, Srinagar.
- The selected candidates shall not claim for any regular appointment as the positions are purely temporary.
- No TA/DA will be paid for attending the Walk-in-Interview.
- The Director, ICAR-CITH, Srinagar reserves the right to terminate his/her services without any notice at any time and the decision of the Director, ICAR-CITH, Srinagar will be final and binding in all respect.
- Candidates shall bring original qualification at the time of interview for verification alongwith one full copy of marksheets duly self attested, publications, experience, and other documents.
- Candidates should attend the walk-in-interview following SOP's issued by Ministry of Home affairs as well as Union territory of J&K.
